The Exploratory Award is a fixed contribution contract. Therefore, particular emphasis is placed at the stage of negotiation, during which the estimated costs are assessed by the Commission services. The assessment is on the basis of the project budget indicated on the Analytical Table of estimated eligible costs.

#### Estimated Eligible Cost categories

#### 1. Personnel

Only the estimated costs of the scientific and administrative personnel directly employed by the participants and assigned wholly or partially with the work under the project (gross remuneration and related charges), may be indicated. The estimated personnel costs shall be based on the rates used in accordance with the normal practices of the participants and the estimated hours required for the work under the project, provided that such costs are regarded as being reasonable by the Commission.

#### 2. Travel and subsistence

The estimated travel and related subsistence costs for personnel working on the project may be indicated. Such costs shall be based on the usual rules of the participants.

#### 3. Subcontracting

Please indicate the estimated costs of subcontracts related to the project, provided that such costs are based on the principles of subcontracts that are awarded and concluded in accordance with the usual procedures of the participants and are in accordance with market prices.

#### 4. Computing

The estimated computing costs, including estimates resulting from the use of computer services and infrastructure at the disposal of the participants, may be indicated. They must be based on the usual rules applicable to the participants.

#### 5. Overheads
